# POLICIES

**BOOKINGS:** A signed bridal agreement and a \$50.00 nonrefundable deposit are required for all bridal bookings. The deposit will be applied towards the total amount due. A minimum of **four (4) clients** is required to secure a booking on a Friday or Saturday.

**CANCELLATION POLICY:** Any cancellations or rescheduling requests will be communicated to the artist as soon as possible. If paid in advance, the remaining balance is fully refundable if canceled at least 90 days prior to the client's reserved date.

**DEPOSIT:** Please send your \$50 nonrefundable deposit to Lauren Doll via **Venmo:** @Lauren-Doll-4 or **Paypal:** [paypal.me/laurendoll](https://www.paypal.me/laurendoll). If you prefer cash/check payments, please contact Lauren directly. Bookings are not considered confirmed until the deposit has been received.

**PAYMENT:** The final balance is due on or before the day of the event and before the artist departs. The person(s) responsible for the entire balance of payment is the person(s) whose name(s) appear on this agreement. Accepted forms of payment include: cash, check, card, PayPal, and Venmo. A transaction fee of 3% will apply to all card payments.

Gratuuity is not expected but always appreciated.

**EARLY CALL TIME FEE:** A \$50 fee will be added to the balance for appointments beginning before 8:00 AM.

**TOUCH-UP SERVICES:** Available upon request and **MUST** be booked in advance along with the bridal booking. Following the complimentary 15-minute period provided for minor touch-ups, any additional time will be billed at a rate of \$60.00 per hour. By proceeding with services beyond the complimentary period, the client acknowledges and agrees to this rate.

## TRAVEL FEES:

**Standard Travel:** Within 3 hours of Denver

- \$.75/mile applies to any mileage over 20 from the artist's residence.

**Destination & Elopement Travel:** Over 3 hours from Denver

- Locations over 3 hours from the artist's residence may require airfare, 1-2 nights accommodation, and transportation to/from the venue. A flat rate will be charged and will cover all travel costs.

**International Travel**

- International locations will require airfare, 3 nights accommodation, and transportation during that time. A flat rate will be charged and will cover all travel costs.

**LIABILITY:** All brushes, tools, and makeup products are sanitized between every makeup application. Any allergies and/or skin conditions should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reactions. Client(s) agree to release the makeup artist (Lauren Doll) and all other artists working on behalf of Makeup by Lauren Doll & Co. from liability for any skin complications due to allergic reactions. The person(s) whose names are listed on this agreement are responsible for any damage or theft.
