

POLICIES

BOOKINGS: A signed bridal agreement and \$50.00 deposit are required on all bridal bookings. The deposit is fully refundable if canceled 90+ days prior to the event. **A minimum of 4 for a bridal party is required to book, or the equivalent \$ amount if you have less than 4.**

CANCELLATION POLICY: Cancellations must be made at least 90 days prior to the client's reserved date, or the \$50 deposit is no longer refundable. If paid in advance, the remaining balance is fully refundable if canceled at least 60 days prior to the reserved date.

PAYMENT: The final balance is due on or before the day of the event and before the artist departs. The person(s) responsible for the entire balance of payment is the person(s) whose name(s) appear on this agreement. Accepted forms of payment include: cash, check, card, PayPal, and Venmo. A transaction fee will apply to all card payments.

Gratuity is not expected but always appreciated.

EARLY CALL TIME FEE: A \$50 fee will be added to the balance for appointments beginning before 8:00 AM.

TOUCH-UP SERVICES: Available upon request and **MUST** be booked in advance, preferably along with the bridal booking. The initial touch-up service charge of \$60 may be subject to an additional \$60/hour for services lasting longer than one hour.

TRAVEL FEES:

Standard Travel: Within 3 hours of Denver

- \$.75/mile applies to any mileage over 25 from my residence.

Destination & Elopement Travel: Over 3 hours from Denver

- Locations over 3 hours from my residence may require airfare, 1-2 nights accommodation, and transportation to/from the venue. A flat rate will be charged and will cover all travel costs.

International Travel

- International locations will require airfare, 3 nights accommodation, and transportation during that time. A flat rate will be charged and will cover all travel costs.

LIABILITY: All brushes, tools, and makeup products are sanitized between every makeup application. Any allergies and/or skin conditions should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reactions. Client(s) agree to release the makeup artist (Lauren Doll) and all other artists working on behalf of Makeup by Lauren Doll & Co. from liability for any skin complications due to allergic reactions.
